Brother Swanger appointed Brothers to replace absent officers!

The meeting was called to order by JVC Swanger at 2:02 PM.

The Minutes from the April meeting were read and accepted.

Treasurer David Demmy, Sr. reported that funds available in our checking account as of the May meeting are \$951.

A motion was made by Brother David Klinepeter to accept the Secretaries and Treasurer's reports and was seconded by Brother Bill Kuhn. Motion approved.

#### **Orders, Communications and Bills**

Brother Tony Kline read correspondence from the Pennsylvania Department in the form of Department Orders. These included the following:

Department Order #18 suspending Camps #34 and #48 for failure to file Form #27 on time.

Department Order #19 describing the origin of Memorial Day and reminding all Camps to get involved in various events to pay respect and remember all veterans at this special time.

Department Order #20 reinstating Camp #34, but suspending Camps #89 and #504.

### **Unfinished Business**

The Adopt-A-Position for cleaning a site at the Gettysburg Battlefield was discussed. A suggestion was made to wait until the September camp meeting to set a date for the cleanup. Brother David Demmy, Sr. made a motion, seconded by Brother Vernon Stout to have Secretary Greg Kline pick several possible dates and send out a dispatch questionnaire to the camp membership and report the responses back to the camp. Motion approved.

Brother David Demmy, Sr. mentioned that again, this year, Camp #15 will be decorating veteran's graves at the Old Harrisburg Cemetery at 13<sup>th</sup> and State Streets at 9:00 a.m. on Saturday, May 23. If anyone is interested, we meet at 8:00 a.m. for breakfast in the back room at the American Dream Restaurant and go to the cemetery from there.

Brother Treat's request to have service bars made for campaigns in Panama and Grenada was discussed. Brother David Demmy, Sr. mentioned that the Office of the Secretary of Defense posts acceptable wars and unless they are on the list National SUVCW [probably] would not create them.

#### **New Business**

On Saturday, May 23 Brother David Klinepeter is accompanying Helen Shireman to a cemetery in Norristown to place a wreath on General Hartranft's grave. Brother David made a motion, seconded by Brother William Jackson to give him a blank check, he will use it to pay the cost of the wreath, give the check to Mrs. Shireman and then he will reimburse Camp #15 for the amount. Motion approved.

### **Patriotic Instructor**

Patriotic Instructor David Klinepeter mentioned that the Ephraim Slaughter ceremony will be held Wednesday, May 27 at 9:00 a.m. in the National Civil War Museum. He reviewed a list of Time Line Dates of Battles, beginning with the revolutionary war up to Operation Iraqi Freedom. He gave a brief history of the GAR and noted General Logan's setting the date of May 30 as Decoration Day, which became Memorial Day in 1882. Brother David displayed several items of Memorial Day memorabilia including old photos, sheet music and several books about Abraham Lincoln.

After the closing ritual ceremony, the meeting ended at 3:30 PM. The next meeting will be held Sunday, September 20, 2015 at 2:00 PM.

# Two Horses

Just up the road from my home is a field, with two horses in it.

From a distance, each horse looks like any other horse. But if you stop your car, or are walking by, you will notice something quite amazing....

Looking into the eyes of one horse will disclose that he is blind.

His owner has chosen not to have him put down, but has made a good home for him.

This alone is amazing. If you stand nearby and listen, you will hear the sound of a bell. Looking around for the source of the sound, you will see that it comes from the smaller horse in the field.

Attached to the horse's halter is a small bell. It lets the blind friend know where the other horse is, so he can follow.

As you stand and watch these two friends, you'll see that the horse with the bell is always checking on the blind horse, and that the blind horse will listen for the bell and then slowly walk to where the other horse is, trusting that he will not be led astray.

When the horse with the bell returns to the shelter of the barn each evening, it stops occasionally and looks back, making sure that the blind friend isn't too far behind to hear the bell.

Like the owners of these two horses, God does not throw us away just because we are not perfect or because we have problems or challenges.

He watches over us and even brings others into our lives to help us when we are in need...

Sometimes we are the blind horse being guided by the little ringing bell of those who God places in our lives. Other times we are the guide horse, helping others to find their way....

Good friends are like that... You may not always see them, but you know they are always there... Please listen for my bell and I'll listen for yours, and remember...

# <u>PATRIOTIC INSTRUCTOR/GAR HISTORIAN</u> by Dave Klinepeter

Your Patriotic Instructor was quite busy the latter part of May and during June. I was asked to accompany Mrs. Helen Shireman (her late husband, Ronald was a member of Camp 15 for many years, also Mrs. Shireman is the great granddaughter of General John F. Hartranft) to Montgomery Cemetery in Norristown, Pa on May 23rd for Memorial Day Services. We placed a wreath, from Hartranft Camp 15, on the grave of General Hartranft. There was a small parade to a number of graves, with brief comments, placing a wreath, firing a salute and taps. The last stop was the Veterans plot. What impressed me, was after the comments, the people, especially the children, took a hand full of rose pedals and spread them on each veteran's grave, than the rifle salute and taps was sounded. While having refreshments later I was able to meet an old friend of Camp 15: Brother John McNulty, PDC, attends our camp Christmas party each year.

On May 25th I was at the Gettysburg National Military Park as a volunteer with the Victorian Dance Ensemble. Talked with a number of men about the SUVCW but most were out of state so I give them info on how to call National Headquarters.

On May 27th I attended the unveiling of the Ephraim Slaughter exhibit at the National Civil War Museum in Harrisburg, Pa. Our Brother David Demmy Sr., Executive Director SUVCW, was on the program and gave a brief history of the GAR.

I was acknowledged as having been on the rifle team that fired the salute over Slaughter's grave in 1943. (I was 16)!

This funeral service occurred before I departed Harrisburg for the US Navy during WWII.



On May 30th (the real Dedication Day) I went to the Lincoln Cemetery in Susquehanna Township with friends and relatives of Slaughter for a wreath laying and special

services. I represented Camp 15 SUVCW. (We were the ones that handled the original military services.)

On May 31st, I went with Mrs. Shireman to Pennypacker

Mills, Pa. to a Civil War reenactment to meet Mark Grimm. He portrays General John F. Hartranft in an organization known as the Confederation of Union Generals. Each member portrays a particular Union officer, (there are a few civilians mixed in) She has helped him with research about General Hartranft. On June 6th the V F W Post in Lower Paxton had an open house honoring Memorial Day, D-Day and Flag Day. They also had a flag burning ceremony. A number of other members of VFW, American Legion and other veteran organizations were in attendance. I informed them about the WWII roundtable, the Vietnam Veterans round table, the Civil War roundtables, and the SUVCW. attend of these most roundtables

during each month. Am always ready to talk up the Son

of Union Veterans.

On June 20th, Mrs. Shireman and I were invited on a bus trip to Washington D C at Fort Meir for a movie making session on the Lincoln Conspiracy trial. This was not a reenactment but an educational movie. The Confederation of Union Generals are very strongly involved. Of interest is the fact that General John F. Hartranft was the Provost Marshal in charge of the trial. This taping was in the original court room at the fort. It was quite a learning experience for me. July 7, 1865 was the hanging.

This year I did not go to the Battle of Gettysburg (it was cancelled because of soggy fields.) There were numerous other activities going on, but I decided to stay home all three days. Have a safe summer and God Bless you and God Bless USA. DjK

GAR General Order No. 9 1876

# Grand Army of the Republic,

No. 920 WALNUT STREET.

PHILADELPHIA, Feb. 15th, 1876.

 $egin{array}{ll} General & Orders \ No. & 9. \end{array} \}$ 

I. Headquarters has been established, in conjunction with the Department of Pennsylvania, at 920 Walnut Street, Philadelphia, where all communications will be hereafter addressed.

The rooms are fitted up with a view to the convenience of Comrades visiting the City, who are cordially invited to make use of them.

It is requested by the Chairman, that communications for the Centennial Committee G. A. R., be sent to the above address.

II. It seems necessary to call attention to the fact that Orders and Circulars from National and Department Headquarters must be read to the Post at the next meeting after their receipt, and then be filed with the Post records.

Where action thereon is required, the Post Commander will call the matter up in the regular order of business.

III. On receipt of this Order, Post Commanders will report to Department Headquarters what numbers of the printed proceedings of the National Encampments are on file with the Post records.

IV. A Provisional Department, to embrace the state of Maryland, is hereby established, and Comrade E. B. TYLER, Baltimore, is appointed Commander.

Comrade J. C. STONE, Burlington, is hereby announced as Commander of the Provisional Department of Iowa, vice Comrade J. C. PARROTT, relieved at his own request.

The following appointments on the staff of Comrade Stone are approved:

A. A. G., Comrade A. A. PERKINS, Burlington.

A. Q. M. G., Comrade ED. L. HOBERT, Burlington.

The appointment of Comrade B. F. CLARK, Quincy, as S. V. C., Provisional Department of Michigan, is hereby approved.

The above-named Comrades, as appointed, will be obeyed and respected accordingly.
