CC&R Article II Membership

Section 3 (a). A Brother whose dues are not paid by **March 1 may be dropped for nonpayment of dues** by Camp. A Brother so dropped shall not be admitted to another Camp or membership-at-large unless having received the concurrence of the Camp which dropped him.

A Brother so dropped from the rolls of a Camp shall be issued a General Discharge for the Good of the Order.²⁴ A Brother may be reinstated by paying the current year's dues [camp and department national per capita] plus a [national] reinstatement fee of ten dollars (\$10.00)!

For 2025 until any future increase in national per capita and/or PA Dept dues, the total reinstatement is **\$60.00** all-year-long and *may not be prorated*.

<u>Reading and Approval of Camp Meeting Minutes as</u> <u>printed in the Hartranft Herald:</u>

The Minutes of the January meeting were read by Commander Kyle. A motion to accept the minutes as read by Brother Jeff and seconded by Brother Chuck. Motion passed.

Treasurer's Report:

Brother David reviewed the status of the three banking accounts the Camp has. They are a checking account, a saving account, and a Supplemental account. At this time all three accounts have respectable balances. Brother David warned balances will change downward as the yearly expenses will need to be paid. Also members of Camp 15 need to pay their dues for 2025 by the end of February!

A motion by Brother Wayne and seconded by Brother Jeffrey to accept the treasurer's report. Motion passed.

Brother David also thanked members of Camp #15 Council for arriving early this afternoon and doing the yearly audit of the Treasurer's Books. Brother Wayne and Brother Jeffery completed that task, and everything appeared to be in order.

Commander Kyle referred Brothers to the latest Hartranft Herald for those who need our prayers.

From the Visiting Committee, and the Investigating Committee:

No activity at this time.

Reading and disposing of orders, communications, and bills:

All orders from the Pennsylvania Department, and the National Office SUVCW, are collected by Brother David and e-mailed to our members to view. Brothers check emails in your in box to view!

Today, Camp Commander Kyle has authored Camp 15, Order #1. It is in reference to Brother Charles "Chuck" Brackbill. Chuck has volunteered to become Camp #15 Counselor. Thank you and congratulations Chuck!

Old Business:

Brother Logan bought us up to date on the "Last Veteran's "Program. He said there is a Civil War Veteran grave in Juniata County. Possibility of visiting his grave and conducting the Last Veteran ceremony in the fall of 2025.

Unfinished Business:

Brother Chuck reviewed with the "Camp 15 Hartranft" shirt project. The design looks great! The next step is for National to review and approve the design to get the ball rolling. More information to come. [post meeting note: Chuck will be meeting with local company in very near future to establish a deal for polo/golf shirts for camp brothers use and other style shirts for each brothers personal needs.

Brother Wayne is the Eagle Scout Coordinator. He asked where the local Boy Scout Council is located. Logan mentioned it is the "New Birth of Freedom Council". Brother Wayne will go through the process of finding a contact person. The question was raised, what is the current status of the SUVCW certificate since there are no more Boy Scouts of America? Now it is "Scouts of America". National SUVCW office is supposedly modifying the current Eagle Scout certificate.

New Business:

Brother Jeff our Patriotic Instructor, explained he needs our Camp 15 brother's to fill out SUVCW form 40 which focuses on volunteer hours they did promoting the SUVCW. Once completed, please bring them to the Camp meeting in February, and return them to Brother Jeff.

Commander Kyle reported Camp 19 raising money for the repair of the General John F. Reynolds grave site in Lancaster County. A motion was made by Commander Kyle, and seconded by Brother Chuck, for Camp 15 to donate \$20 to the cause. All were in favor. This will take place after a review by Camp 15 Council. Motion passed.

Commander Kyle said he will establish 2 new committees. One titled "Grave Registration and Last Veteran Committee". The second one is titled Recruiting and Fund-Raising Committee. Brother Logan will head the Grave Registration Committee. The Recruiting and Fund-Raising Committee may be headed by Brother Scott Debo, with Commander Kyle and Brother Chuck assisting. Brother David was asked to please check with the Civil War Museum when the next scheduled Public Open House is. Camp 15 would like to participate.

A very large metal GAR star grave flag holder was donated to SUVCW. Camp 15 will place this item at the grave site of General Geary in the Harrisburg Cemetery on Saturday May 24th.

At the Harrisburg area holiday luncheon for camp 15 held on

December 21st, one of the many conversations was about the WWII war years steel pennies. A sample display was pictured in the January newsletter and David handed out a steel [silver looking] penny to each brother present at the January meeting. Also, David recently acquired an 1890 newspaper, *The Sunday Capital* [of Harrisburg] which highlighted an article on General Hartranft. Brother Chuck hopes to extract text from this newspaper to produce snippets that can be used for Parts I and Part II articles in forthcoming *Hartranft Heralds*. Also David shared an old photo that included former Camp Commander David J. Klinepeter, along with a cousin of our own David Demmy Sr.,[Don Demmy Wagner], and last but not least a gentleman named Charlie Oellig. [all 3 were members of Knaps Battery]. Charlie lives in the Harrisburg area and has quite a collection of Civil War and military items. Charlie expressed he will open his home museum to a few camp 15 visitors weather permitting this spring.




