Camp Commander Brother Kyle Purchase opened the meeting according to the SUVCW Ritual. The time was 2:07 P.M.

Reading and Approval of Camp Meeting Minutes as printed in the Hartranft Herald:

The Minutes from the last meeting was read by Commander Kyle. A motion to accept the minutes as read/printed, by Brother Logan and seconded by Brother Chuck. Motion passed.

Brother David reviewed the status of Camp 15's Brother's Dues renewal status for 2025. All dues were due by the end of February and they are to be sent to Camp Treasurer David Demmy Sr. Reminders for paying the dues have been in the Hartranft Herald for the past **three months!** Brother Wayne reported that two more actions took place to try to get dues payments. The first one was sending personalized e-mails to Brother's who had not paid their dues. The second was personalized USPS post cards sent to each Brother who had not paid dues. Commander Kyle stated that it appears that Camp #15 has done our "due diligence" on this subject. Those who did not pay will be dropped from the roster. In the near future if they wish to be reinstated to the SUVCW it will cost them \$60 [including national fee of \$10 and late payments may be prorated through the year]. . Brother David handed out 2025-26 Camp #15 membership cards to those in attendance. All other treasury account balances basically remained the same. Motion to accept the Treasurer's report was made by Brother Dan and seconded by Brother Chuck. Motion passed.

Department Commander Brother Bill Fischer requested by May 15th a report on Graves Registration in reference to activities of Camp #15. Commander Kyle welcomed PA Department Senior Vice Commander, Brother Mike Peter, as a quest today at our meeting. Commander Kyle spoke about date and program for the "Last Civil War Veteran for Juniata County." It will be sometime in the fall for this event. Brother Logan stated that he is checking at the Susquehanna Mennonite Church. He will keep us up to date for a service there too. Brothers are to review their Fall 2025 calendar for possible good date(s) for these events.

Reading and disposing of orders, communications, and bills:

In review, all orders from the Pennsylvania Department, and the National Office SUVCW, are collected by Brother David Demmy Sr. and e-mailed to our members to view. Brothers check emails in your in box to view! But if you missed an order, go to the Pennsylvania Dept., SUVCW web page, and the national site of the SUVCW, and you can see them all! For today's meeting Commander Kyle read one from the National Commander in Chief, Brother Martin, addressing the "160th Anniversaries of the Civil War". Another order read was announced the passing of a Past National President of the Women's Relief Corp's, Sister Cynthia L. Norton.

Finally the last National Order announced the passing of Brother John C. Rutheford, PDC Department of Missouri. In a communication Senior Vice Commander, Michael Peter initiated a request that he needs by April 19, 2025, information/articles from the PA Camps for a shorten future issue of The "Battle Cry of Freedom". Brother David passed around a newsletter from a former Camp #15 member who transferred into a Florida camp a few years ago. This brother is now on the editorial staff of that newsletter.

Old Business or Unfinished Business:

Commander Kyle reported, via Camp 15 P.I., Brother Jeff Smith, Form #40 was submitted to the PA Department P.I. Camp #15 for processing. Bylaws refresh/review committee continues. Brother Scott had a chance to look over our current Camp Bylaws. He stated in his view there is no need for any adjustments. Brother Chuck hopes to perform the same task by the next meeting.

New Business:

The Camp #15 Hartranft shirt project. Chuck and David continue to iron out all the many specifics and challenges concerning this project. They will keep us up to date. At the appropriate time, it appears the shirt will be available through the printer's web site. Stay tune!

SUVCW Form 27 will be worked on by Brother's David and Wayne. It is due April 30th 2025, to the Department Secretary.

Brother David spoke about the possibility of finding any Brother having a license to sell items on E-Bay? Maybe he would be interested in selling our Belt Buckle and License Plate via his E-bay account for the benefit of the camp? Let Brother David know if you would like to help in this venture.

Testimonial Dinner in Scranton for Department Commander William Fischer is scheduled for March 22, 2025. Carpooling is being planned.

Good of the Order:

Commander Kyle shared the importance of having associate members in our Camps. Also, Brother Kyle will be doing a presentation at a History Fair sponsored by the "Crooked Billet Association" in Hatboro, PA on April 26, 2025.

Brother Kyle shared a series of colorized photos of GAR members at the various monuments in Gettysburg. One being the dedication of the Zook monument, located along Wheatfield Road. The veterans in the photo are from Zook Post #11 from Norristown, PA.

There is interest in having a joint meeting/event with the Fischer Baker Camp #101 in the future.

Brother Logan shared with the group that The Association of Gravestones Studies, is having their yearly event in York Pa this year, from June 17th through June 22nd. The home base will be York College. Contact Logan for details.

Brother Wayne shared with the group he has finally had a chance to meet the new Executive Director of the Montgomery County Historical Society David Young. I'll be working with him, in ordering a wreath for the Hartranft monument for Memorial Day.

Brother Michael Peter encouraged Camp #15 members to attend the PA Department yearly Encampment in Cranberry Township, PA. June 19 – 22, 2025.

Brother David stated the 2025 Holiday Christmas Party may return to Harrisburg and be co-hosted by Camp #15, along with 2-3 other interested sister camps. The key is to invite other Camp's to attend, to make it a successful <u>co-camps</u> event! Committee discussion down the road......

Editorial

CAMP 15 SHIRT PROJECT

UPDATE

The Camp 15 Shirt Project, which was suggested more than five years ago, has reached the point when we will soon be able to purchase Camp 15 shirts.

BACKGROUND

An ad hoc committee of four brothers (David Demmy, Logan Swanger, Kyle Purchase and Chuck Brackbill) met on 2 November 2024 to conceive a design for the artwork for the shirts. It was agreed that the design should consist of a keystone, an image of General Hartranft, and the words SUVCW, Hartranft, Camp 15 and Harrisburg in Union blue and gold inside the keystone. A collective effort produced the design below:



Actual size of the image should be 2 ½ x 2 ½

Camp 15 promptly submitted a request to National SUVCW for a license to produce the shirts for camp use. Approved license on file.

PRODUCTION OF SHIRTS

Chuck interviewed two companies that put images on shirts, Rowe Screen Print of New Cumberland and Shenk Company of Mechanicsburg. At a monthly meeting of Camp 15, the brothers decided that the Shenk Company is best suited to produce the Shirts.

Depending on the on the level of detail we want in the image of General Hartranft, the shirts can be produced using screen printing, embroidery, or a combination of the two. Embroidered images last longer than printed images, which eventually fade. Further discussion with Shenk Company is needed to decide on the imaging process that best suits our needs.

Images can be put on different kinds of shirts and other apparel such as baseball caps and on objects such as coffee mugs. The brothers agreed it that Union blue short and long sleeve polo Shirts are the most desirable. In addition, some brothers would like short sleeve dress shirts. Sweatshirts might be a good option for others.

PURCHASE OF SHIRTS

Shenk Company will create a website that our brothers may use to order and pay for shirts. It will be most economical if the shirts are imaged in a single production run, so orders will not be fulfilled at the time the order is placed.

REASONS TO HAVE CAMP 15 SHIRTS

There are several reasons to have Camp 15 shirts.

- 1 We can wear them when we do tabling and recruiting events.
- 2 They will give our brothers a unified, professional appearance.
- 3 When we wear them in our everyday lives, people will ask what SUVCW is and that might help with recruiting new brothers.
- 4 We can wear them when we go on *camp field trips* or visit schools to do educational presentations.
- 5 They will promote Camp 15 esprit de corps.

ORDER RECOMMENDATIONS

It is highly suggested that each brother that is interested and able make a purchase, to please order at least 1 **navy blue**, **short-sleeve polo shirt** so during the wearing, all brothers present, have look alike *esprit de corps* shirts.

In addition, any brother may order other shirts: long sleeve, short sleeve, dress shirts, sweatshirts etc. in a choice of multiple colors.

As soon as Shenk provides a website, we will gladly pass it along to all brothers of camp 15. A brother suggested that we may order different shirts for different options and make purchases of shirts too for grandkids etc.


